ORDER

1(i) An ex-cadre post of Inspector General of Police, Kerala State Human Rights Commission is created in Level 14 of the Pay Matrix with Pay Scale Rs. 144200-218200 for a period of one year with effect from 01.08.2023 and the post is declared equivalent in status and responsibility to the cadre post of Inspector General of Police, Headquarters, under Rule 12 of Indian Police Service (Pay) Rules, 2016.

(ii) An ex-cadre post of Deputy Inspector General of Police, Anti-Terrorist Squad is created in Level 13A of the Pay Matrix with Pay Scale Rs. 131100-216600 for a period of one year with effect from 01.08.2023 and the post is declared equivalent in status and responsibility to the cadre post of Deputy Inspector General of Police, Administration, under Rule 12 of Indian Police Service (Pay) Rules, 2016.

2. Shri T.K Vinod Kumar IPS (KL:1992), Additional Director General of Police, Intelligence is promoted to the grade of Director General of Police in the scale of pay of Rs. 205400 - 224400 (Level 16 of the Pay Matrix), w.e.f 01.08.2023. The promotion is ordered with the concurrence of Government of India as stipulated under Rule 3 (2) (i) of Indian Police Service (Pay) Rules, 2016, vide letter read as 2nd paper above.

(v) Shri. M.R Ajithkumar IPS (KL:1995), Additional Director General of Police, Law & Order is given full additional charge of the post of Additional Director General of Police, Armed Police Battalions.

(vi) Shri. Balram Kumar Upadhyay IPS (KL: 1997), Additional Director General of Police, Headquarters is transferred and posted as Director General of Prisons & Correctional Services, vice Shri. Shri K. Padmakumar IPS (KL:1989) transferred.

(vii) Shri. H.Venkatesh IPS (KL: 1998), Additional Director General of Police, Crimes is given full additional charges of the post of Inspector General of Police, Cyber Operations and Inspector General of Police, State Crime Records Bureau.

(viii) Shri P. Prakash IPS (KL:2004), Inspector General of Police, Intelligence is transferred and posted as Inspector General of Police, Kerala State Human Rights Commission in the ex-cadre post created vide para 1(i) above.

(ix) Shri K. Sethu Raman IPS (KL:2004), Inspector General of Police & Commissioner of Police, Kochi City is transferred and posted as Inspector General of Police, North Zone, vice Shri. Neeraj Kumar Gupta IPS (KL: 2005)

transferred.

(x) Shri Neeraj Kumar Gupta IPS (KL: 2005), Inspector General of Police, North Zone is transferred and posted as Inspector General of Police, Headquarters.

(xi) Shri A.Akbar IPS (KL:2005), Inspector General of Police, Traffic & Road Safety Management is transferred and posted as Inspector General of Police & Commissioner of Police, Kochi City, vice Shri K. Sethu Raman IPS (KL:2004) transferred.

(xii) Shri Putta Vimaladitya IPS (KL:2008), Deputy Inspector General of Police, Kannur Range is transferred and posted as Deputy Inspector General of Police, Anti-Terrorist Squad in the ex-cadre post created vide para 1 (ii) above.

(xiii) Shri Thomson Jose IPS (KL: 2009), Deputy Inspector General of Police, who is reporting to the cadre on 01.08.2023 on repatriation from Central deputation, is posted as Deputy Inspector General of Police, Kannur Range.
